

Now through Nov. 17: Free Living Will and Power of Attorney Documents

Has money, time or fear kept you from creating important healthcare legal documents, such as a Living Will and Power of Attorney? You should consider developing these documents if you are the parent of minor children, own property or want to have a say in your healthcare treatment. And for this limited time period (through Nov. 17), you can have your own personal documents created for free through ARAG - First Data's Legal Plan Administrator.

- **Healthcare Power of Attorney** – this document empowers you to name someone who can make important medical decisions on your behalf if you are unable to make them yourself.
- **HIPAA Authorization (Patient)** – a form that allows trusted family members or friends to view your medical records and health information when you have been injured. These records are typically used to help prove whether you are capable to make healthcare and financial decisions on your own, and therefore could activate a Healthcare Power of Attorney or a Durable Power of Attorney that you signed when healthy.

How it Works – Getting Started is Easy

- If you are not currently enrolled in the ARAG legal plan: Visit www.ARAGLegalCenter.com and enter **Access Code: 10335fdc**.
- Click on the *Free Online Legal Documents* promotional banner.
- Select *New Account*.
- Complete required information – including establishing a user name and password – and click *Submit*. You will receive a registration confirmation via e-mail for safekeeping.
- After you have set-up your account, you will be logged in as a member to the ARAG Living Wills site. Choose the *Online Documents* tab and follow the instructions to create your documents.

If you are an existing member of the ARAG legal plan, you already have access to these documents and more. Simply login in as a member at www.ARAGLegalCenter.com and go to *Online Resources* to locate Do-It-Yourself Legal Documents™ or call for document preparation with an attorney.
